**NOTICE OF RISK**

I, the undersigned, do hereby understand and agree that skateboarding contains significant inherent and other risks that could lead to serious injury, including permanent disability or death. I understand and agree that these significant inherent risks increase when I am in the presence of or skateboarding on ramps, steps, half pipes, inclines or declines, bowls or any other structure or device that I may utilize while skateboarding at the Grind Lab Indoor Skatepark. I understand and agree that these risks include, but are not limited to: uncontrolled boards, falling, jumping, landing, performing tricks and colliding with other users, staff and spectators. I understand and agree that these risks further increase when other persons of all levels of experience and skill are skateboarding at the Grind Lab Indoor Skatepark at the same time that I am present and/or skateboarding at the Grind Lab Indoor Skatepark.

I have read, understand, and will follow or ask for an explanation of all the rules, policies and responsibility codes that are posted at the Grind Lab Indoor Skatepark. If, however, I observe any unusual significant hazard during my presence or participation at the Grind Lab Indoor Skatepark, I will remove myself from participation and bring such attention to the nearest employee, official or agent immediately. I further understand that the employees and officials of the Grind Lab Indoor Skatepark are expected to enforce rules, conduct and behavior. My violation of the rules, policies and responsibility codes may result in disciplinary consequences, including permanent expulsion from the premises, with no refund of any fees paid on my behalf.

I further accept, understand and agree that if I am over the age of eighteen years of age and choose not to wear a helmet and/or protective gear, including knee and elbow protection, while engaging in the sport of skateboarding, such choice could lead to my serious injury, including permanent disability or death.

I accept for use, AS IS, the Grind Lab Indoor Skatepark.

**ASSUMPTION OF RISK**

Understanding, acknowledging and agreeing to all of the risks involved, I hereby agree to expressly and voluntarily accept and assume all risks, whether known or unknown, involved in my presence or participation in any activity whatsoever at the Grind Lab Indoor Skatepark, even if arising from the negligence of others, and assume full responsibility for my

presence and/or participation.

**RELEASE OF LIABILITY**

In consideration of being allowed to be present or participate in any activity whatsoever at the Grind Lab Indoor Skatepark, and all other related events and activities, I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby agree not to sue and to release the Grind Lab Indoor Skatepark, as well as its members, agents, employees, officials, other participants, volunteers, vendors, exhibitors, sanctioned events, sanctioned organizations, sponsoring agencies, sponsors, advertisers, and owners and lessors of premises of the Grind Lab Indoor Skatepark from any and all liability related to all injury, disability, death or loss or damage to person or property incident to my presence, involvement or participation in any activity whatsoever at the Grind Lab Indoor Skatepark, regardless of any negligence on the part of the same. I further agree to indemnify and defend the same from any claim for liability related to any and all injury, disability, death or loss or damage to person or property incident to my presence or participation in any activity whatsoever at the Grind Lab Indoor Skatepark, regardless of any negligence, recklessness or improper conduct on the part of the same.

I agree that all disputes arising under this Waiver, Release & Assumption of Risk Agreement shall be litigated exclusively in the Court of Common Pleas of Cumberland County or in the United States District Court for the Middle District of Pennsylvania. Further, this Waiver, Release & Assumption of Risk Agreement is governed by the applicable laws of the Commonwealth of Pennsylvania. If any part of this Agreement is determined to be unenforceable, all other parts shall be given full force and effect.

If I do not agree with the above, I will not be present or participate in any activity whatsoever at the Grind Lab Indoor Skatepark.

I, the undersigned have read, understand and agree to be legally bound by this Waiver, Release & Assumption of Risk Agreement. I attest that if I engage in the sport of skateboarding at the Grind Lab Indoor Skatepark, I am physically capable of skateboarding and I do not have a medical condition that would cause my participation in skateboarding at the Grind Lab Indoor Skatepark to be potentially hazardous to my health.
